COMMENCEMENT OF AGREEMENT

This Agreement becomes effective when you agreed to the terms and conditions of this Agreement by accepting, installing, using, accessing or manipulating the SOFTWARE.

DURATION

This Agreement is one-year contract renewable to the option of the user (YOU). The AUTOAGENT software is provided as packages. All packages are renewable after one year of usage from the time of subscription, and each package has its own price. Once you have joined to use AUTOAGENT software you will be given a default package with limited features. This default package will be valid only for this period and after ending of this period you will be required to renew to other available packages of your choice.
